# LIABILITY WAIVER

## Waiver and Release of Liability and Indemnity Agreement

IN CONSIDERATION of being permitted to participate in a SUPER STAR SPORTS program and to enter and engage in athletic events at Designated Areas at various facilities and/or locations, the undersigned, for himself and his personal representatives, assigns heirs, and next of kin, agrees, and on the direct representation that he has or will inspect the Designated Area(s) of the facilities and/or locations where the athletic event(s) is(are) held and that they are safe and reasonably suited for the intended purposed for which the Waiver and Release applies, and now therefore the undersigned:

1. **HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE**, Super Star Sports, LLC., their representatives, officials, owners, coaches or team members, used to conduct the athletic event(s), and each of them, their officers and employees, hereinafter referred to as **RELEASEES**, from all liability to the undersigned, whether caused by negligence of releasees or otherwise, while the undersigned is in the Designated Area(s), and practicing, competing, observing, working for or in any way participating in the athletic event(s); and,
2. **HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS, AND COVENANTS NOT TO SUE** the releasees for any loss, liability, damage, or cost they may incur due to the presence of undersigned in or upon the Designated Area(s), or in any way, competing, observing or working and trying out, or for any purpose participating in the athletic event(s), and whether caused by negligence of the releasees or otherwise; and,
3. **THE UNDERSIGNED** expressly acknowledges and agrees that the activities of the athletic event(s) are dangerous and involve the risk of serious injury and/or death and/or property damage. The undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the province or state in which this athletic event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
